I continue a number of ongoing voluntary roles, as Trustee with the National Federation of Parks and Green Spaces and Vice-Chair of Green Tides, the Adur and Worthing Green Spaces Partnership. Additionally, I volunteer with Worthing Climate Action Network, building relationships locally to deliver climate change information and action. This includes organising, managing and speaking at events, leading initiatives and undertaking supporting roles for other projects. Recent achievements include co-organising the Zero 2030 conference and acting as Advisory Board Member for the Adur and Worthing Citizens Climate Assembly.

- Contacts made during my previous career have allowed me to deliver a strong partnership approach when considering strategic sustainability. I was particularly keen in introducing and building relationships between external organisations and clients with whom collaborations may be beneficial.

- Responsible for promoting best practice and environmental policy amongst local authorities and other conservation organisations, a network numbering 500 contacts, through a regional forum, sub-regional groups and email communication. Working on behalf of members to ensure that partnerships secured with other organisations directly benefit the region, including funding and training opportunities.
- Skilled communication at all levels required from strategic planning at national forum level to practice discussion with local authority or community groups. Ongoing delivery, development and monitoring of the forum's action plan and long-term strategic aims. Provision of expert assistance to local authorities; for example, acting as critical friend during the development of Oxford City Council's Green Space Strategy, involvement in a European funded shared learning project between Rother District Council and the Belgium city of Ooestende and speaking at a variety of events about green infrastructure.

- Projects include the development of an online discussion forum, events and training delivery, including the Green Flag Award
  national standard for parks and green spaces and green infrastructure Masterclasses, regular news updates and conference
  reports and the annual regional conference. Also, responsible for overall management of related administration systems
  including finance.
- Attendance at regional and national level working groups with partner organisations to understand and disseminate the latest sector projects and opportunities. Both roles aim to influence and advocate to central and local government policy makers the importance of green infrastructure in line with the latest research and evidence.
- The policy and research role required an up-to-date knowledge of the latest studies related to green infrastructure and the built environment within the wider context of sustainable urban growth.

#### Jan '07 to Dec '09 Borough Council of King's Lynn and West Norfolk, Greenspace Project Officer

- Busy and varied role working for the Improving Neighbourhoods Board (INB), a multi-agency and resident group, which oversaw the £3.7m Safer, Stronger Community fund, of which £2.1m was for the Cleaner, Greener programme for five disadvantaged neighbourhoods in King's Lynn. From this £600k of capital projects were allocated and completed, forming a community park spaces network of six play sites and one entire park redesign, plus additional neighbourhoods grant programme, other tenders and funding bids.
- Initially carried out a large-scale green space audit including mapping, database and final report, which informed the INB
  action plan leading to my subsequent responsibility as landscape architect and project manager. My contract was extended
  in August 2007 and I was promoted in April 2008.
- I planned and managed all these projects from inception, community engagement strategies and planning, to overseeing the contractors on site, evaluation and promotion of the final outcomes. Where required, I organised outside skills and assistance to progress the various projects, for example commissioning artists to engage and develop ideas with children and communities.
- Fully responsible for all allocated budget management, including grant application submissions, collating all necessary information and producing business plans.
- Working in the public sector established a broad range of experience and transferable skills that fell on the periphery of my
  original position, such as inclusion in Council steering groups regarding regeneration and planning for King's Lynn and West
  Norfolk. This was coupled with extensive training, including CABE Space Leaders programme.
